

BLACK HAWK COUNTY HOUSING PROJECT

Over the past year, we have been in discussion with the Otto Schoitz Foundation to think big around the idea of ending homelessness in Black Hawk County. I never saw this opportunity coming and was so excited to think about building programming that would make such a large impact. Many days and nights were spent researching and developing the plan. I talked with leadership internally and several programs across the state and started to finalize the dream. In March, we received word that the project was funded, and it was now time to think about implementation. So here we are ready to launch the Black Hawk County Homeless Project on August 1st.

We will be working to bring local providers together to develop a by-name list of people experiencing homelessness and provide up to 60 units of rental assistance monthly. This will include the use of highly intense case management, developing budget and employment skills, creating opportunities for connection into the community, and conducting street outreach in the county.

We are so excited for what this project can accomplish, and we thank Otto Schoitz Foundation for having faith in us. We learn to be better every single day and in the end, we have one vision "Everybody has a Home".


